personally before me and provided information concerning the above-named defendant of the crime(s) of COUNT I, SEXUAL ABUSE OF A CHILD, a Felony, Idaho Code §18-1506(1)(b), COUNT II, RAPE, a Felony, Idaho Code §18-6101(4), committed as follows:

COUNT I

That the Defendant, SEAN ALEXANDER BARRON, on or about the 26th day of September, 2021 in Kootenai County, Idaho, did, while being sixteen (16) years of age or older, and with the intent to gratify the lust, passions, or sexual desire of the defendant, cause or have sexual contact with A.A.B, a minor child under the age of sixteen (16) years, to-wit: 12 years of age years of age, by touching her all over her body and/or touching her buttocks;
